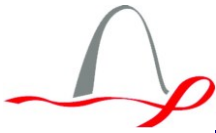

Surveys

Provider and Case Manager surveys will be administered on opposite years from the client survey (2013, 2015, etc) and should include both MO and IL agencies. New-to-Care surveys will be administered every year or on an ongoing basis.

Focus Groups

Client focus groups will be administered on the opposite years from the Client survey (2013, 2015)
Provider and Case Manager focus groups will be administered on opposite years of the Provider and Case Manager surveys (2012, 2016, etc)
Primary Care Provider focus groups began in 2012

Other Groups

Additional needs assessment focus groups will be performed as the NACP Committee deems necessary.
Town Hall Meetings are scheduled each year, however, not all town halls include content that is relevant for needs assessment. Town Hall Meetings are planned by members of the Needs Assessment and Comprehensive Planning Committee.
